#### Resolution

The Executive Council of Vidyasagar University noted that a group of students in the Department of Anthropology has submitted the above mentioned letter stating that the marksheets in 1st & 3rd semesters in Anthropology - 2012 which they obtained from the University stated as M.A. in Anthropology. The Executive Council also noted that the Department of Anthropology is under the Faculty of Science so the degree should be awarded M.Sc. in Anthropology. #### Resolution

The Executive Council of Vidyasagar University noted that the Principal, Silda Chandra Sekhar College has submitted the above mentioned letter along with the Government Orders stating that D.P.I.'s Order No. 390(2) Edn CS dated 05.04.1999 regarding attending college for 180 teaching days in an academic session by a teacher is not being fulfilled. The order was subsequently revised by the University authority and reduced to 150 days from 180 days which contradicts with the G.O. All the Universities are following 180 teaching days as per D.P.I.'s order. The Executive Council also noted that in the said order it is stated that the work load of a teacher who should be available in the college for at least 5 hours daily and twenty five hours minimum in a week but the University issued a circular stating that a teacher shall remain in the college at least 25 hours per week ignoring minimum 5 hours daily. In this connection he has submitted the above mentioned letter requesting the University authority to take necessary steps in this connection in compliance with the Government Order.

After threadbare discussion on the matter and careful consideration of the Order of the D.P.I. it was resolved that a Committee consisting of (a) the Principal, Mahishadal Raj College, (b) the Principal, Belda College and (c) the Inspector of Colleges(Convener) be constituted to look into the matter and to submit a report in this connection for further consideration.

The Executive Council also noted that the construction work of the University Auditorium has been stopped and enquiry of construction of the Auditorium is going on. Nirman Private Limited it was resolved that the prayer relating to release of 80% payment as an Ad-Interim towards 3rd R/A Bill for construction of Auditorium of Vidyasagar University made by them be regretted as the enquiry of the construction of the Auditorium is going on.*


