HISTORY

Resolutions adopted at the Departmental Committee meeting held on 10 June 2014 (deferred from 4 June 2014):

- 1. Resolutions of the last meeting held on 22 May 2014 be confirmed.
- 2. The revised MA syllabus (briefly, Mr. Shyamaprasad De and Dr. Debjani Das to offer 1 optional course in III Semester and 2 new optional courses in III and IV Semesters respectively; Ms. Shamita Sarkar to offer her optional course in the IV Semester) be placed at the meeting of the Joint Faculty Council to be held on 17 June 2014 so that it be adopted in the academic year 2014-2015. Also, due to the paucity of time, the external members of the PG BoS be apprised of the syllabus and their consent be taken by e-mail or in person.
- 3. As regards the e-mail of Mr. Abhijeet Paul of University of California at Berkeley from the Hon'ble Vice Chancellor, the Head confer with the Development Officer to explore possibilities of inviting him and apprise the VICE chancellor about it; as regarding his query as to why Dr. Sujaya Sarkar did not communicate to him about the matter, Dr. Sarkar herself apprise him about it.
- 4. In view of an application from the outgoing IV Semester students requesting for publication of their result within three weeks, effort be taken to publish it within 45 days (the time stipulated by the university, according to the Dean of Arts and Commerce), i.e., 25 July.
- 5. Suggestions regarding the seminar to be held on 16 & 17 July 2014 be conveyed to the co-ordinators of the seminar from time to time.
- 6. The new III Semester students be given a week to convey their optional paper choices.

7. Mr. G. C. Roy be the editor of the forthcoming departmental journal of 2014-2015.

This has reference to Dr. Sujaya Sarkar who suggested that I write to you about a possible Visiting Professor appointment at Vidyasagar University in 2015. She is cc-ed here.

Earlier, I had written two general emails to both of you expressing my initial interest in teaching at Vidyasagar University. Encouraged by Dr. Sarkar to write a specific one, I am pleased to attach a course proposal sheet and my curriculum vitae.

In 2015, I will be in Kolkata and West Bengal from **April to December**, **2015**. I shall be doing research and revising my book on labor, technology, and ethics with a focus on South Asia. I shall also likely be holding one more Visiting appointment elsewhere.

I believe both are directly connected to a variety of research areas, including Women's Studies, the Humanities, and other interdisciplinary studies in general. You may note, I taught similar courses in Women's Studies, Jadavpur University in 2011.

I am also open to teaching courses in a) postcolonial theory and b) labor, technology, and ethics if you so wish. I noticed that the History department is strong in the sub-discipline of history of technology. My current specialization is in the history of junk and repair work in the context of global works. Please let me know what suits you.

I very much look forward to discussing this with you further as well as spending my time at Vidyasagar University in 2015.

1. CULTURE AND GENDER

This postgraduate/M.phil./Ph.D./Refresher course engages recent debates on and forms of analysis of culture and gender history/anthropology by addressing the question of methodology and its theoretical and practical implications in research. However, instead of focusing on the collection of data and the archives, the course grounds students in the history and theory of methodology first. This simply means, students read a variety of texts in the fields of Critical Theory, Social and Political Theory, and Gender to form an overarching idea of the theoretical field studied widely today. The central question in this formulation is the question of power and ideology in the construction of social identities. The first part

The course is spread across 3 months (1 meeting for 1.30 hours per week=12 meetings). The final assessment will be based on producing 2 short essays (in English or in Bengali).

The course will be in English but lectures and discussions can be done in Bengali, if necessary.

[N.B.]: The format of the above course is subject to revision, depending on student needs.

Note on readings:

Core and additional readings are from the following books and articles by authors who can be roughly periodized as classical, modern, and contemporary. The readings address a) modernity, culture, and sex/gender; b) ethnography and its problematic; c) domestic/public dichotomies; d) colonialism/race/caste and sex/gender with specific references to anthropology, South Asia, and the hijra identity.

Reddy: takes up Cohen's ethnographic question, or does she? How does she overcome some of the questions that Cohen raises?

Does she alter her position as an ethnographer? Does she perceive or lets herself be perceived and then approach her subject of hijras in Hyderabad/Secunderabad area?

2. METHODOLOGY: THEORY and PRACTICE

This core methodology course is open to **postgraduate/M.Phil./Ph.D.** students and scholars doing research in the humanities and the interdisciplinary fields of history, anthropology, women's studies, gender, sociology, and related areas. The course is theory based and proper attention is given to elucidating concepts, their theoretical structures, and application to individual research projects. The course welcomes participation across the humanities and social sciences as these research tools are widely used in academic disciplines. Students should preferably have taken the first course (Culture and Gender) as prerequisite. However, students may take this course independently as well.

Methodology is understood as both a <u>tool box</u> as well as a <u>problematic</u> (in the Althusserian sense) in examining the complex nature and stature of sex/gender relations in culture and society. Sex/gender history/anthropology draws on a variety of disciplines and sub-disciplines besides ethnography: political economy of sex and gender and its critique, psychoanalysis, philosophy, cultural studies, humanities, and, of course, history. The course focuses on the problem of *category*, which is often seen as originating in ideas of <u>heteronormativity</u>. With this basic research problem in mind, we will read and discuss a variety of works on modernity, sex/gender, and culture (by Michel Foucault, Judith Butler, Gayle Rubin, and others). We will read commentators on non-western and South Asian debates on culture and gender (Lawrence Cohen, Ann Stoler, Gayatri Reddy, and others).

The timeline for this course is 3 months (1 meeting for 2-2.5 hours per week=12 weeks). Students are expected to write a research paper (15-20 pages) using techniques learned in class
