


Resolution of the Ph.D. Meeting in Commerce held on 07.08.2014 :

1. The proceedings of the earlier meeting held on 29.11.2013 has been read and confirmed.
2. The two candidates namely Mr. Bijay Krishna Bhattacharya and Mr. Sibram Chatterjee have presented their pre submission seminar in the Department of Commerce before the expert members of the Ph.D. Committee. Recommendations and suggestions, if any have been noted in their respective forms of pre-submission. Both the candidates have been allowed to submit their thesis with minor change in case of Mr. Bhattacharya, panel of adjudicators of both the candidates was placed by the respective supervisors to the Ph.D. Committee and the same was approved by the Committee.
