রেজল্যুশন / Resolution Adopted

- ① Meeting began with greetings to the expert. The proceedings of the last meetings were confirmed.
- ② Miscellaneous:
  - a) The proposal of Rituparna De for Title change of PhD thesis is accepted & she is allowed to present her pre-submission seminar titled "Investigation on the causes on tuberculosis among ethnic communities of Thargram, West Bengal, India."
  - b) The prayer for changing PhD title of Mahesweta Chatterjee is accepted. The title is being changed from "Cadmium-induced carcinogenesis-remedies by application of potential herbal extracts & homeopathic drugs" previously to the present as "Study on the effect of Cadmium as the Inductive carcinogenic agent and its amelioration by *Phyllanthus emblica* and *Lycopodium 200C* using animal model."
  - c) The prayer of Sujoy Midya for title change is accepted. The title previously as "Ecological assessment of Estuarine stretch with special reference to zooplankton" is being modified to "Ecological assessment of zooplankton and bacterial interaction in two contrasting aquatic ecosystems - estuarine and fresh-water in South West Bengal, India".
  - d) Prayer of Subhasri Middya for extension of six months is accepted. Experts recommend. presubmission and thesis submission must within this tenure.
  - e) Prayer of Sayan Bhattacharya for extension of 6 months for PhD thesis submission is accepted and permitted.
  - f) Prayer for extending duration of PhD. thesis submission of Sujoy Midya is permitted for six months only.


(g) The prayer of Hirulal Pakhira for re-registration is accepted considering all the facts and note submitted by the supervisor (certificate attached). He is permitted for the same as per University rules with effect from 13.12.16. (date of expiry of previous registration)

(h) The application of Dipesh Kr. Das for Ph.D. extension is not being accepted.

(h) In relation to application of Madhuchhanda Duari (Rakshit), if the candidate fulfils the criteria of UGC 2009 regulation, then the Equivalent certificate may be issued to the candidate.

(2) For departmental criteria regarding Ph.D. supervision by teachers of V.V.-affiliated colleges, the points for consideration are :-

- Ph.D. degree is mandatory for supervisor himself.
- 5 years of research experience in the respective field that is supported by publications in peer-reviewed journals.
- Desirable condition preferably is having a research project grant from authorised funding agency.

b) Sayan Bhattacharya - "Subterranean Interstitial Fauna of Coastal Midnapore district - Diversity & Ecology"


