Resolution :

1. Proceedings of the previous meeting were read and confirmed.
2. Utsav Roy informed that he was unable to continue his Ph.D. course in Vidyasagar University because he had selected for Ph.D. course in other nearest University. In this circumstance, it was resolved that Sk. Aktar Hossain, Roll No. VU/PH.D./PH/74, SL. No. 1 of the Waiting list of the final list of eligible candidates to be admitted to the Ph.D. programme, 2013 in order of merit is eligible to admit to the Ph.D. programme in place of Utsav Roy (copy of his letter enclosed). The other four candidates (2-5) presented their Ph.D. proposals (for ^{Ph.D.} registration) before the members of the Ph.D. committee and all the proposals except that of Sonali Paul were approved by the members of the committee with some changes or revisions according to their suggestions. ³⁰ But Amit Pan, Alok Ranjan Khata and Sk. Asrafur Islam were advised to submit revised

proposals accordingly. But the proposal of Sonali Paul was not approved by the members of the committee. She is required to submit a fresh proposal and to appear before the committee for pre-registration seminar again.
