Resolution of the DC meeting (Ref. No.: VU/PG/Chem/162 Dated 25.02.2016)

1. The resolutions of the last DC meeting held on 23.12.2015 was read and confirmed.
2. The departmental committee finalized the Chemistry (M.Sc) Syllabus in relation to the CBCS for onward submission to the competent authority.
3. The HOD informed the DC about the possibility of conducting the forthcoming practical practice and examination for M.Sc in Chemistry in distance mode. In view of the ongoing renovation work in the laboratories it was resolved that the department is not in a position to conduct the aforementioned practice and examination. HOD was requested to inform the Director, Directorate of Distance Education (DDE), Vidyasagar University in this regard. Also it was resolved that the practical practice and the examination may be conducted in any authorized study centre which may be decided by the authority.
4. Miscellaneous:
 - a. The DC recommends the submission proposals (Two) of Prof. Ajay Kumar Misra entitled (i) "Synthesis of Low Dimensional.....Nitro Aromatics" (DRDO) and (ii) "Synthesis of Functional.....Heavy Metal Ions" (SERB).
 - b. The DC recommends the submission proposal of Prof. Amiya Kumar Panda entitled "Physicochemical.....delivery systems" (SERB).
 - c. Prof. Amiya Kumar Panda reported that the proposal for conducting two days Science Academies' Lecture Workshop (April 21-22, 2016) has been approved. In this connection the authority may be requested in opening a bank account in name "SCIENCE ACADEMIES' LECTURE WORKSHOP" in the UCO Bank, Vidyasagar University Branch. The account may be jointly operated by Amiya Kumar Panda (as Coordinator), Ajay Kumar Misra (as Member) and Sudipta Dalai (as Teacher-in-Charge). DC unanimously resolved that B.N. Sasmal Hall will be suitable for this lecture workshop and the coordinator is hereby requested to do the needful for the booking the said hall.
 - d. The DC unanimously resolves to start the Ph. D. course work for the academic session 2014-15 and 2015-16 jointly in the month of May-2016.
