1. Resolved that the timetable for PCP (DDE) ~~has~~ Part I has been discussed. Dr Indrani Datta Choudhuri has agreed to act as a Co-ordinator of the PCP (DDE) Part I. The classes will start on 2 May 2017 and the span of the classes will be from (2-11) May 2017.
2. Resolved that the parent-teacher committee has been formed. And the student-teacher committee was also formed. The first meeting of these two committees will take place on 25.04.17 at 1:00 pm.
3. In the DC meeting held on 19.04.2017 Dr Indrani Datta Choudhuri challenged the presence and participation of Prof. Tirthankar Das Purkayastha in the deliberations of DC meeting, on the ground that he is a re-employed teacher ~~teacher~~ of the Department. She claimed that as a re-employed teacher Prof. Tirthankar Das Purkayastha lacks the locus standi for giving any opinion in the meeting. The committee strongly feels that this is an insult to a senior teacher of the Department and resolves that the matter be brought to the notice of the Hon'ble Vice Chancellor for his kind opinion.
4. The DC strongly feels that Dr Indrani Datta Choudhuri's behaviour in the DC meeting is ^{becomes} increasingly unacceptable to the members. Her ^{language} is vulgar, abusive and unsuited to the academic environment of the Dept.
