	<p>Agenda 3: The applications submitted by Kankana De and Argina khatum for their pre-submission seminars were placed before the Ph.D. Committee for consideration.</p> <p>In view of incorporation of the socio-economic factors ^{by Kankana De} as suggested by the Ph.D. Committee in its meeting dated 24.09.2014, the Ph.D. Committee unanimously resolved that Kankana De shall be allowed to proceed for Pre-submission seminars.</p> <p>However, in case of Argina khatum, the committee unanimously resolved that in view of the circular of UGC bearing No. F.10-6/2011 (PS) Misc. dated 06.07.2015 and non-compliance of the resolution (No. 1) adopted in the Ph.D. Committee meeting held on 11.04.2012, the name of Ashish Mukhopadhyay as Co-Supervisor of Argina khatum shall be deleted/struck out and Prof. Kaushik Shankar Bose will be the lone supervisor of Argina khatum. The committee further resolved that the Secretary of the Ph.D. Committee shall be take necessary action so that a fresh/corrected version of certificate of registration may be issued by the office of the Registrar, VU in favour of Argina khatum with effect from 08.11.2012.</p>
