Agenda 1 :- The proceedings of the previous PhD Committee meeting held on 13. 08. 2018 were read and confirmed.

Agenda 2 :- The Secretary placed before the Ph.D committee members the documents of 03 (three) candidates namely Bazibrata Giri, Shahbaz Hussain, and Swarup Pratihar which have come from the PhD Section, VU to conduct the pre-registration seminars of these candidates. The committee members unanimously resolved that the pre-registration seminar of Bazibrata Giri could not be held since his supervisor Prof. Dipak K. Midya could not attend the meeting. The other two candidates Shahbaz Hussain and Swarup Pratihar were permitted to present their pre-registration seminars. The two candidates gave their pre-registration seminars before the committee members. After due deliberation the committee members resolved that the candidates may be permitted to proceed with their Ph.D. work.

(ii) A letter along with the attached photocopies of the "provisional offer to the research student under INSPIRE fellowship (DST/INSPIRE/03/2017/003319 dated 19.12.2017)" and "final list of eligible candidates to be admitted to the Ph.D Programme 2018," of Ms. Samarpita Paul, former student of the Department of Anthropology, VU, dated 04.10.18 addressed to the Hon'ble Vice-Chancellor through the Dean, Faculty of Science, VU was placed before the Ph.D Committee by the Secretary, Ph.D Committee as per the note by the Dean, faculty of Science on the body of the letter dated 10.10.2018.

It was learnt from the letter of Ms. Samarpita Paul that she was shortlisted for the DST-INSPIRE fellowship as early as 19th December 2017.

The members of the Ph.D committee after due deliberations on the letter of Ms. Samarpita Paul unanimously resolved the following points.

- (a) It is surprising that a prospective Ph.D candidate was informed the Hon'ble Vice-chancellor about her provisional selection for the DST-INSPIRE fellowship after 08 (Eight) months of the provisional award.
- (b) The members of the Ph.D committee put it on record that the application of Ms. Samarpita Paul for DST-INSPIRE fellowship was not forwarded and/or endorsed by any faculty of this department in the capacity of her prospective supervisor(s) at the initial stage. Furthermore, Ms. Paul did not also discuss or consult any faculty of the Department of Anthropology on her specific research topic to be undertaken by her for the DST-INSPIRE


