#### Resolutions:

1. The Resolutions of the last meeting held on 27/6/19 read and confirmed.
2. M.Phil Coordinator Prof. Chhanda Ghoshal Submitted a Resignation letter to the H.O.D . As advised by the Hon'ble Vice- Chancellor the letter is placed before the Committee for Consideration. All members of the Committee requested Prof. Chhanda Ghoshal to continue the coordinatorship. But she denied the request. She argued that she has been working with many disturbances as follows :
  - 1.The result of M.Phil 2<sup>nd</sup> semester was published in the absence of M.Phil external member.
  2. Controller of Examination didn't send her the scheduled of the M.Phil Viva-Voce and Publication date of the result.
  3. Head of the Department didn't pay her probable travelling expenses for the external member from midnapore station to vidyasagar university in advance.

The matter will be discussed later in the presence of Dean, Arts & Commerce.

3. Dr. Saroj Kumar Pan expressed his anger for distribution of syllabus before the scheduled meeting. And he said that it is not possible for him to teach the 'sriyaman Bangl Sahitya'.

The H.O.D advised Dr. Pan to Control his temper and discuss with good manners. Head of the Department explained that the syllabus has been primarily distributed and placed before the committee for consideration. It is not an illegal process. He distributed the Learning Courses among the teacher earlier as the routine needed to be prepared before starting 3<sup>rd</sup> Semester classes. *Dr. Malanki Sarker was requested to make a proposal on "Bangladeshi sahitya" for introducing certificate Course in the Department. Dr. S. Pan also requested to make a Course proposal on manuscriptology for certificate course, if possible.*

Miscellaneous:

A. Byanbanarna foundation and Bengali Department Jointly organize a seminar in November 2019. Prof. Chhanda Ghoshal and Dr. Saroj kumar pan were the joint Conveners. The Accounts have not been Submitted as yet. Committee requested them to submit the Accounts as early as possible.

B. It has been decided that at faculty members must be submitted their progress report of assignment allotted to them for NAAC purpose within 16/07/2019.

C. Prof. Monanjali Bandyapadhyay placed the Resolutions of the parent-Teacher committee meeting held on 11/7/2019 for consideration. After thorough discussion the resolutions was approved.

D. Committee resolved that the teacher should be applied for leaves according to University rules.

E. The Head requested to the teacher to change their preparatory - day as only one teacher (except H.O.D) attend the department on Friday. But all the teachers refused the request.

F. As per direction (VC/3088(a)/2019, Dated 26/6/2019) of the Hon'ble Vice-Chancellor we discussed about incorporation of Sahitya Academe's monograph as a part of our curriculum. But suitable monographs are not found.
