	1. The decisions made during the last DC meeting (Meeting No. 58 held on 23 rd July 2025) were reviewed and approved in the current meeting.
	 It was resolved that, in line with the discussions of the NEP Syllabus Committee and the structure prescribed by the University, the Departmental Committee shall convene further meetings as necessary to prepare a comprehensive NEP 2020-based Postgraduate syllabus. Dr. Sumana Bera submitted an application seeking Child Care Leave for the period from August 26, 2025, to September 12, 2025, to attend to her daughter during her Half-Yearly (Class X) Examinations.
