Departmental Committee Meeting (Meeting No. 59, Dated: 13.08.2025)

Members present:

The members of the DC have reached a unanimous decision concerning the matters outlined in the agenda:

1. The decisions made during the last DC meeting (Meeting No. 58 held on 23rd July 2025) were reviewed and approved in the current meeting.
2. It was resolved that, in line with the discussions of the NEP Syllabus Committee and the structure prescribed by the University, the Departmental Committee shall convene further meetings as necessary to prepare a comprehensive NEP 2020-based Postgraduate syllabus.
3. Dr. Sumana Bera submitted an application seeking Child Care Leave for the period from August 26, 2025, to September 12, 2025, to attend to her daughter during her Half-Yearly (Class X) Examinations. The Committee noted that this is Dr. Bera's second application for Child Care Leave in the year 2025. After careful consideration, the Departmental Committee resolved to forward the application to the University authorities for their kind consideration and necessary action. The Committee further advised Dr. Bera to ensure that academic, research, and administrative activities of the Department, including the studies and examinations of Postgraduate students and research scholars, are not hampered during her period of absence.
4. Based on the marks obtained in the previous semester examinations and in accordance with the PG syllabus, the students of the 3rd Semester (2025) are required to select one optional subject from Group A (PHI-303A or PHI-303B) and one optional subject from Group B (PHI-305C or PHI-305D). Following

this procedure, the students have made their selections, and the Departmental Committee has confirmed the list of approved candidates.

As there were no additional issues to discuss, the meeting came to a close, leaving participants with heartfelt best wishes for their future endeavours and accomplishments.
