

রেজল্যুশন / Resolution Adopted

The members of the DC have reached a unanimous decision concerning the matters outlined in the agenda:

1. The decisions made during the last DC meeting (Meeting No. 60 held on 29th October 2025) were reviewed and approved in the current meeting.
2. The Departmental Committee discussed the Workshop on Mental Health, Self-Awareness, and Philosophical Counselling, scheduled for December 3rd and 4th, 2025. The resource persons for the workshop are Professor Soumitra Basu and Professor Samar Kumar Mandal from Jadavpur University, Kolkata. To facilitate participation, the Committee has set a registration fee that is accessible: Rs. 700/- (seven hundred) for teachers, Rs. 500/- (five hundred) for research scholars, and Rs. 250/- (two hundred fifty) for student participants. All responsibilities related to the workshop have been assigned to the Joint Coordinators: Professor Jhadeswar Ghosh and Dr. Sreejith K. K.
3. Dr. Sumana Bera submitted an application seeking Child Care Leave for the period from November 18, 2025, to December 3, 2025, in order to support her daughter during her Pre-Board Examinations. After careful consideration, the Departmental Committee decided to forward her application to the University authorities for further review and action. The Committee also advised Dr. Bera to ensure

that the Department's academic, research, and administrative activities, including the studies and examinations of postgraduate students and research scholars, are not disrupted during her absence.

4. The Departmental Committee reached a unanimous decision to name Dr. Sreejith K. K. as the Coordinator for the Placement Cell.
5. The Departmental Committee convened to deliberate on the formation of the Departmental Purchase Committee, which is essential for overseeing procurement processes within the department. After thorough discussion and careful consideration, the committee unanimously decided to assign Dr. Shewli Dutta and Dr. Sreejith K. K. as members of this committee.
6. The Departmental Committee reached a unanimous decision to name Dr. Sumana Bera as Coordinator for the Teacher-Parent Committee.
7. During the Miscellaneous agenda, the Committee concentrated on enhancing the Class Routine for the first semester of 2025.
