Thereafter as per the decision of the EC in its meeting dated 22.01.2014 his suspension order was withdrawn and accordingly he has reinstated in his duty in this University with effect from 06.02.2014. After reinstating he applied for payment of his 50% unpaid salary during his suspension period from 11.02.2010 to 05.02.2014 withheld with this University and as per the decision of the EC in its meeting dated 03.04.2014 his prayer regarding the unpaid salary during his suspension was regretted. The Executive Council also noted that now he has filed the above mentioned writ to the Hon'ble High Court against the University authority pertaining to payment of 50% of withheld salaries during his suspension period together with multiple interest @Rs.10% per annum till date of actual payment.

After thorough discussion on the Writ Petition bearing W.P. No. 2961(W) of 2015 filed by Shri Surajit Sen, Technical Assistant Gr.-I of this University against the University pertaining to payment of 50% of withheld salaries during his suspension period together with multiple interest @Rs.10% per annum till date of actual payment, it was resolved that a Senior Lawyer of the Hon'ble High Court be appointed for this particular case. Resolved also that the matter be left to the Hon'ble Vice-Chancellor for necessary action.

After thorough discussion on the letter submitted by the Secretary, Governing Body & D.D.O., Yogoda Satsanga Palpara Mahavidyalaya pertaining to enhancement of fees structure of M.Ed. Course, it was resolved that in anticipation of the G.O. of Higher Education Department, Government of West Bengal, the prayer for enhancement of fees structure of M.Ed. Course is deferred.*

- 06(c) To place before the Executive Council the letter bearing File No. 51-4/2014/NCTE/N&S dated 16.12.2014 received from the Chairperson, National Council for Teacher Education, New Delhi pertaining to implementation of Recognition Norms and Procedure Regulations, 2014 of National Council for Teacher Education.

As the new regulations have come into force with immediate effect, the admissions of students in these programmes in the session starting July/August, 2015 shall be made for a duration of two years. This shall necessitate revision of syllabi, scheme of examination, eligibility conditions, etc. with the approval of the competent bodies of the University and requested the University to set up an appropriate mechanism at V.U. for development of courses, scheme of examination etc. for the programmes of two years' duration.*

*After thorough discussion on the letter received from the Chairperson, National Council for Teacher Education, New Delhi pertaining to implementation of Recognition Norms and Procedure Regulations, 2014 of National Council for Teacher Education, it was resolved that in anticipation of a uniform syllabi from the Higher Education Department, Government of West Bengal, the matter be dealt with subsequently.*

It is a statutory Govt. norm that the physically challenged persons enjoy 75% exemption in case of payment of fees and in all spheres of their leading daily lives. Considering the outstanding services for the Visually Impaired persons in the country the RCI has conferred award "Excellence in Achievement", the Ministry of Social Justice & Empowerment, Govt. of India and also Govt. of W.B. bestowed with National Award : 2013 as the best individual and the Vivekananda Mission Asram in the country. In connection with the above they approach the University authority to look into this special type of institution for Visually Impaired on a compassionate feelings and to waive the revised fees-structure as a special case.*

No. 604 of 2013 are initiated at Vidyasagar University so that human rights of TG students are safeguarded and their mainstreaming is fast-tracked within University and society at large.

After thorough discussion on the letter received from the Secretary, University Grants Commission, New Delhi pertaining to uphold the transgenders' right to decide their self-identified gender, i.e. male, female or as third gender as a way of safeguarding and enforcing appropriately their rights under the Constitution in order to ensure removal of the discrimination and deprivation suffered by Transgender Community in Indian Society, it was resolved that the Dean, Faculty Councils for Postgraduate Studies in Arts & Commerce and Dean, Faculty Councils for Postgraduate Studies in Science be requested to organize a workshop in this regard.

- 06.(n) To discuss the matter pertaining to introduction of verification of certificates/testimonials from the competent issuing authority regarding recruitment of staff (teacher, officer & non-teaching) at Vidyasagar University.

**Resolution:** The Executive Council of Vidyasagar University noted the proposal prepared and submitted by the Establishment Section of the Office of the Registrar, Vidyasagar University stating that at present there is no rules/provisions for verification of educational and other certificates/testimonials from the competent issuing authority. As per the present practice of the Government, the policy for verification of the same may be initiated in this University before joining of any incumbent in any post in this University to avoid the fake/baseless/ tampered certificates/documents.

After thorough discussion on the proposal submitted by the Establishment Section of the Office of the Registrar, Vidyasagar University pertaining to introduction of verification of certificates/testimonials from the competent issuing authority regarding recruitment of staff (teacher, officer & non-teaching) at Vidyasagar University, it was resolved that the documents/testimonials pertaining to recruitment of all staff of this University be verified by the Establishment Section before joining of any incumbent in this University or during the probation period of the incumbent concerned. Resolved also that the Establishment Section of this University will take care for such activity. In future a separate Cell may be constituted for this purpose.

- 06.(o) To place before the Executive Council of Vidyasagar University the letter dated 05.02.2015 submitted by Dr. Abhijit Guha, Associate Professor, Department of Anthropology of this University along with the Certificate awarded to him by the Board of IJMAS pertaining to inclusion in the said certificate in his service book and career record at Vidyasagar University.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 05.02.2015 along with the Certificate awarded to him by the Board of International Journal of Multidisciplinary Approach & Studies (IJMAS) in recognition of publication of the paper entitled "Corruption in a University in West Bengal, India : A First Person Narrative" submitted by Dr. Abhijit Guha, Associate Professor, Department of Anthropology of this University requesting to incorporate the said certificate in his service book and career record at Vidyasagar University. The Executive Council



also noted the content of the Certificate awarded by the Board of IJMAS in this respect.

After thorough discussion on the letter submitted by Dr. Abhijit Guha, Associate Professor, Department of Anthropology pertaining to inclusion in the said certificate in his service book and career record at Vidyasagar University and careful consideration of the Certificate awarded by the Board of IJMAS, it was resolved that the matter be turned down as per the practice of Vidyasagar University.

- 06.(p) To place before the office note dated 04.01.2014 prepared and submitted by the Deputy Controller of Examinations of this University pertaining to the proposal for enhancement of the examination fees for each semester of Paramedical courses in BMLT & DOCA.

**Resolution:** The Executive Council of Vidyasagar University noted the note dated 04.01.2014 along with the proposal submitted by the Deputy Controller of Examinations stating that the examination department feels that preparation of results of paramedical courses in BMLT & DOCA should be computerized replacing typed Mark Sheet. Besides, the Centre-in-Charge for the concerned examination centre has requested to enhance the centre grant. In connection with the above he has proposed for enhancement of the examination fees for each semester of the above mentioned paramedical courses.

After thorough discussion on the office note along with the proposed enhanced fees semester-wise for Paramedical Courses in BMLT & DOCA prepared and submitted by the Deputy Controller of Examinations, it was resolved that the semester-wise enhanced fees of Paramedical Courses in BMLT & DOCA of this University be accepted and approved for implementation.

**Resolution:** *The Executive Council of Vidyasagar University noted the proposal bearing letter dated 23.02.2015 submitted by the Controller of Examinations proposed that to maintain the confidentiality a 'HOLOGRAM' may be pasted on each of the Marksheets and Certificates which will be issued to the passingout students of Vidyasagar University. About 1,20,000 (one lac twenty thousand) holograms per year are required for this purpose. In this connection he has requested to consider the said matter. The Executive Council also noted that as per the direction of the Registrar, the Programmer and the Information Scientist jointly has prepared and submitted a budgetary provision for two lacs holograms.*

Appearing in front of the members of the cell during the said meeting would stand in violation with the resolution of the disciplinary authority, i.e. Executive Council and hence would be contempt of the Order issued by the Division Bench of the Hon'ble High Court, Calcutta on 25.11.2014.*

*After thorough discussion on the letter dated 19.02.2015 submitted by Dr. Indrani Dutta (Chaudhuri), Assistant Professor, Department of English, now under suspension, pertaining to not attending before the meeting of the Prevention of Harassment Cell of this University scheduled to be held on 25.02.2014, it was resolved as follows :*

- (1) Both the issues are separate, so, there is no need of the charged officer to take permission from the disciplinary authority, i.e. Executive Council and the Enquiry Officer for appearing before the



meeting of the Prevention of Sexual Harassment Cell to present her case.




