Resolved that the decision pertaining to termination of service of Shri Pal from this University has already been taken in item No. 05(e).*

The Executive Council noted further that on the basis of the said letter of UGC, the Hon'ble Vice-Chancellor of this University has constituted a Committee consisting of (a) the Dean, Faculty of Science – Chairman, (b) the Dean, Faculty of Arts & Commerce and (c) the Secretary, Faculty Councils for Postgraduate Studies - Convener to prepare the revised regulations in this regard. The Executive Council noted again that as per the direction of the Hon'ble Vice-Chancellor of this University a notification in this regard has already been served to the University and its affiliated colleges.




