*After thorough discussion on the letter of the University Grants Commission, New Delhi regarding ensuring the number of off-campus/study centre/outreach centre is established by Vidyasagar University outside the territorial jurisdiction of the State, it was resolved that the reply regarding no such off-campus/study centre/outreach is established by the University outside the territorial jurisdiction of the State be sent to the UGC as desired by them immediately. Resolved also that the Director, DDE of this University be requested to communicate the same to the UGC in this regard.*

After thorough discussion on the letter of the University Grants Commission, New Delhi regarding clarifying that an Assistant Professor who completes Ph.D. or M.Phil. Degree within 4 or 5 years from the date of his/her appointment shall also be eligible for moving from the AGP of Rs.6,000/- to AGP of Rs.7,000/- after completion of 4 and 5 years of his/her service respectively. Further, if the incumbent acquires Ph.D./M.Phil. after completion of 4 years of service/5 years of service and before 6 years of service respectively, he/she shall be eligible to move to Stage - II (AGP Rs.7,000/-) from the date of award of Ph.D./M.Phil. Degree subject to the fulfillment of other conditions stipulated in the UGC Regulations, 2010, it was resolved that the said clarification of UGC be accepted. **Resolution :** The Executive Council of Vidyasagar University noted the letter bearing No. VMATCT/475/B.Ed./OBC/Admin/2015-17 dated 31.08.2015 jointly submitted by the General Secretary and the Director of Vivekananda Mission Asram, Training College for the Teachers, B.Ed. Spl. Ed.(V.I.), Chaitanyapur stating that as per the notification of the Jadavpur University and the West Bengal Central School Service Commission they published the advertisement for admission into B.Ed. Spl. Ed. (V.I) Course for the session 2015-2017 relaxing upto 5% in the qualifying marks at the Graduate level of the SC/ST/OBC/PH student and accordingly Rehena Khatun, an OBC-A candidate has been admitted into the said course with relaxation of 5% marks in aggregate. The Executive Council also noted that now they came to know that the OBC candidates will not be allowed to enjoy such relaxation of 5% marks and inadvertently they did not follow the guidelines of Vidyasagar University in this regard. In this connection they have requested the University authority to accord approval for admission of Rehena Khatun into the said course as a special case.

After thorough discussion on the letter submitted by the General Secretary and the Director of Vivekananda Mission Asram, Training College for the Teachers, B.Ed. Spl. Ed.(V.I.), Chaitanyapur pertaining to according approval for admission of Rehena Khatun, an OBC candidate, admitted into B.Ed. Spl. Ed. (V.I.) Course run by VMA in the session 2015-17 as a special case and careful consideration of the norms of the University in this regard, it was resolved that the admission of Ms. Rehena Khatun, an OBC candidate admitted to B.Ed. Spl. Ed.(V.I.) Course of Vivekananda Mission Asram, Training College for Teachers, B.Ed. Spl. Ed.(V.I.), Chaitanyapur with relaxation of 5% in aggregate, which is beyond the University norms,

be accepted as a special case on submission of an undertaking that the VMA authority will not repeat such practice in future and further to abide by the rules and regulations framed by this University in this regard strictly. These students have appeared for Written Examination as per the VUMAT Format and also appeared for Group Discussion and Personal Interview and they have obtained the composite score of above fifty percent. The Executive Council also noted that these students have already started their classes at that Institute. In connection with the above he has requested the University authority to consider the candidature of the students for pursuing the regular M.B.A. degree for the session 2015-2016 keeping in mind their future career. They also ensured that they would comply with the admission guideline of Vidyasagar University from the next academic session onwards.
