Academic Innovations

i) Introduction of new courses in emerging areas with applied orientation with a blend of traditional and non-traditional subjects and specialized courses comprising cross disciplinary learning. For example, a UGC Sponsored Certificate Course in Human Rights has been introduced. Similarly, introduction of an application based One-year PG Diploma course on ‘Quality Control and Assurance in Microbial Technology’ under UGC Innovative Programme has opened up the scope for increasing the employability of the students .

ii) The introduction of autonomous P.G. centres in constituent colleges has continued during the year.

iii) Malaria is the national problem for last 150 years. The need to revise the existing primary treatment strategy for this disease has been highlighted by Prof.Somenath Roy and his team from Immunology and microbiology laboratory of the Dept. of Human Physiology, Vidyasagar University. Findings of their research programme conducted on the community people in the tribal dominated home district of Paschim Medinipur and districts of Bankura and Purulia may ultimately help the Govt. authority of India select proper drug regime against P. falciparum malaria.

Administrative Innovations

The following innovative strategies to bring in improved pace in administrative functioning have continued to yield the desired result:

i) Administration automation, ii) E-tendering,

ii) Uploading of decisions and resolutions of all the statutory bodies like Court, executive Council, Faculty Councils, Board of Research Studies in the official website of the University,

iii) E-based grievance redressal system,

iv) Hot-line (electricity) facility.

Apart from the above mentioned strategies, already in place, the following new strategies have been initiated by the University during the year:

i) High-speed internet accessibility,

ii) Extended computer facility for students and teachers,

iii) Up-gradation of e-library facility,

iv) Advancement of Security system with closed circuit camera,

v) High-powered Generator facility for uninterrupted power supply,

vi) Modernisation of USIC,

vii) Purified, cooled drinking water facility,

viii) Installation of Fire fighting system.

From among many of the activities undertaken by the university, the following two are identified as being the **two best practices**:

(i) Academic innovations:

(a) Introduction of new courses in emerging areas with applied orientation with a blend of traditional and nontraditional subjects and specialized courses comprising cross disciplinary learning;

(b) Introduction of autonomous P.G. centers in constituent colleges.

(ii) Backward area development program through research extension, NSS and post-graduate project work (a component of course curriculum).

7.4 Contribution to environmental awareness / protection

The following practices of the members of University community are having significant impact on protecting the environment and / or creating awareness on the campus:

- i) Inclusion of environment related topics like environmental ethics (ecological, biocentrism, eco-feminist, anthropocentric, etc.), environmental accounting and auditing in the syllabus of different courses (Dept. of Philosophy, Dept. of Geography and Environment Management, Directorate of Distance Education, etc.);
- ii) Researches on various environment related subjects in the Depts. of Philosophy, Dept. of Business Administration and others;
- iii) NSS Cell and different NSS units conduct regular programmes on environmental issues both on the campus and also amongst the community people for creating an awareness to avoid various health hazards;
- iv) Regular monitoring of the Waste Disposal System – garbage, chemical and hazardous waste, and e-waste.
