



- 06(e) To consider the letter bearing No. 445/MRC/Prayer/V.C./V.U./2017 dated 30.12.2017 submitted by the Principal, Mahishadal Raj College affiliated to Vidyasagar University pertaining to issuance of Unique Affiliation Number/Registration No. of each college affiliated to Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing No. 445/MRC/Prayer/V.C./V.U./2017 dated 30.12.2017 submitted by the Principal, Mahishadal Raj College affiliated to Vidyasagar University stating that a Unique Affiliation Number/Registration Number is required for each college to submit different projects to the Ministry of Human Resource Development, Government of India or the University Grants Commission or any other departments of Government of India. In this connection the Principal has requested to make arrangement for issuance of the said number to all the colleges affiliated to Vidyasagar University for this purpose. The Executive Council also noted the alpha-numeric codes prepared and suggested by the Inspector of Colleges of this University replacing the existing college codes based on such letter of Mahishadal Raj College.*

*After thorough discussion on the letter submitted by the Principal, Mahishadal Raj College affiliated to Vidyasagar University pertaining to issuance of Unique Affiliation Number/Registration No. of each college affiliated to Vidyasagar University and careful consideration of the alpha-numeric codes prepared and suggested by the Inspector of Colleges, it was resolved that the said college codes be prepared district-wise and the Inspector of Colleges of this University be requested to process further in this regard.*




- 06(f) To consider the letter bearing No. VU/UE/30/18 dated 17.01.2018 submitted by the University Engineer pertaining to permission for utilization of fund amounting to Rs.44,84,446/- sanctioned by the Department of Higher Education, Science & Technology and Biotechnology, Government of West Bengal, University Branch.

**Resolution:** *The Executive Council of Vidyasagar University noted the the letter bearing No. VU/UE/30/18 dated 17.01.2018 submitted by the University Engineer stating that the Department of Higher Education, Science & Technology and Biotechnology, Government of West Bengal, University Branch sanctioned an amount of Rs.44,84,446/- (Rupees forty four lacs eighty four thousand four hundred forty six) only bearing Memo No. 643(Sanc.)/EHP/Univ/1U(VID)-03/15 dated 06.11.2017 for improvement of Eastern Road by converting to a Black Top Road from the University Auditorium site to Gate No. 3 in the University Campus but due to urgency the said work has already been completed from the MP LAD fund received from Shri V.K. Gupta, Hon'ble M.P. (RS) bearing Memo No. 1598/Dev. dated 08.12.2016. Now the University Engineer has proposed that the said fund of the Higher Education Department may be utilized for repairing of the existing Black Top Road within the academic and residential campus of Vidyasagar University which has already been vetted by the Executive Engineer, N.H. Division-II P.W. Roads Department, Midnapore. In this connection the University Engineer has requested to permit them to do the said repairing work from the sanctioned fund of Higher Education Department.*

*After thorough discussion on the letter submitted by the University Engineer pertaining to permission for utilization of fund amounting to Rs.44,84,549/- (Rupees forty four lakhs eighty four thousand five hundred forty nine) only sanctioned by the Department of Higher Education, Science & Technology and Biotechnology, Government of West Bengal, University Branch, for repairing of the existing Black Top Road within the academic and residential campus of Vidyasagar University which has already been vetted by the Executive Engineer, N.H. Division of P.W. Roads Department, Midnapore in place of improvement of Eastern Road by converting to a Black Top Road from the University Auditorium site to Gate No. 3 in the University Campus for which the amount was sanctioned, it was resolved that the proposal submitted by the University Engineer be declined for this purpose. Resolved also that a Committee consisting of (1) the Registrar, (2) the Finance Officer, (3) the Development Officer and (4) the University Engineer – Convener be constituted to inspect the University Campus in this regard and submit a report which will be placed before the next meeting of the Executive Council for further course of action.*

- 06(g) To consider the letter dated 10.01.2018 submitted by Shri Debasish Das, Senior Assistant of Vidyasagar University pertaining to fitment of his pay with one additional increment to the post of Senior Assistant on promotion.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 10.01.2018 submitted by Shri Debasish Das, Senior Assistant of Vidyasagar University stating that Shri Das along with Shri Nayan Ranjan Mahapatra was promoted to the post of Senior Assistant from the post of Junior Assistant with effect from 02.10.2008. At the time of promotion to the post of Senior Assistant his fitment was made without any additional increment as per norms. Afterthat as per the G.O. of the Higher Education Department, the pay of Shri Mahapatra has been fixed*



with one additional increment. As both of them are promoted to the post of Senior Assistant on the same day and the promotional fitment of Shri Mahapatra has been made with one increment, he has requested to fitment of his pay in his promotional post with one additional increment.

After thorough discussion on the prayer submitted by Shri Debasish Das, Senior Assistant of Vidyasagar University pertaining to fitment of his pay with one additional increment to the post of Senior Assistant on promotion, it was resolved that the said prayer of Shri Das be forwarded to the Department of Higher Education, Science & Technology and Biotechnology, University Branch for their opinion/advise.


- 06(h) To consider the letter dated 08.01.2018 submitted by Ms. Shampa Maity, Senior Peon of Vidyasagar University pertaining to granting of 120 days of leave taken by her for her medical treatment as medical leave instead of Earned Leave on medical ground.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 08.01.2018 submitted by Ms. Shampa Maity, Senior Peon of Vidyasagar University stating that she took leave in two phases (1st phase - 60 days from 26.12.2016 to 23.02.2017 and 2nd phase - 120 days from 07.04.2017 to 04.08.2017) for her treatment at Calcutta and Vellore. The first phase leave of 60 days was granted by the University as medical leave but the second phase of leave of 120 days was granted by the University to her as Earned Leave on medical ground. She has also stated that she has not been cured completely and she will under the expensive treatment for the rest of her life. Her rest of the service period at this University is only three years and she wants to get her leave encashment at the time of her retirement. In this connection she has requested to consider her prayer sympathetically and to allow her 120 days leave as Medical Leave in place of Earned Leave on medical ground so that she can get the full benefit of her leave encashment at the time of retirement.

After careful consideration of the letter submitted by Ms. Shampa Maity, Senior Peon of Vidyasagar University pertaining to granting of 120 days of leave taken by her for her medical treatment as medical leave instead of Earned Leave on medical ground, it was resolved that the said 120 days Earned Leave on medical ground as was granted earlier to Ms. Maity be granted as medical leave subject to admissibility of her medical leave balance as per the norms of the University. Resolved also that the Establishment Section of this University be requested to process further in this regard.

- 06(i) To place before the Executive Council of Vidyasagar University, the letter dated 25.01.2018 submitted by Shri Tapas Kumar Rout, Security Guard of Vidyasagar University pertaining to submission of the original certified copy of the verdict passed by the Honourable Additional District & Sessions Judge, Fast Track Court, Paschim Medinipur regarding his acquittal from the charge under Section 235(1) of Cr. PC as he is found not guilty for commission of offence.

**Resolution:** The Executive Council of Vidyasagar University noted that as per the earlier decision of EC based on the report submitted by the One-man Enquiry Committee constituted regarding continuous absence of Shri Tapas Kumar Rout, Security Guard of Vidyasagar University, Shri Rout was asked to submit his certified copy of the verdict passed by the Honourable Additional District & Sessions Judge, Fast Track Court, Paschim Medinipur regarding his acquittal from the charge under Section 235(1) of Cr. PC. And accordingly he has



submitted a letter dated 25.01.2018 along with the original certified copy of the verdict passed by the Honourable Additional District & Sessions Judge, Fast Track Court, Paschim Medinipur regarding his acquittal from the charge under Section 235(1) of Cr. PC. The Executive Council noted further the detailed certified copy of the said verdict of the Honourable Additional District & Sessions Judge, Fast Track Court, Paschim Medinipur. The Executive Council observed from the said verdict that that Shri Rout engaged himself as Supervisor of Mid Day Meal in the district of Paschim Medinipur although he was an employee of Vidyasagar University and holding a substantive post.

After thorough discussion on the certified copy of the verdict passed by the Honourable Additional District & Sessions Judge, Fast Track Court, Paschim Medinipur submitted by Shri Tapas Kumar Rout, Security Guard of Vidyasagar University regarding his acquittal from the charge under Section 235(1) of Cr. PC as he is found not guilty for commission of offence and subsequently his engagement in a Mid Day Meal in the district of Paschim Medinipur as Supervisor as an employee of Vidyasagar University, it was resolved that an explanation be asked for from Shri Rout as follows :

- (1) whether you had accepted the offer as Supervisor of Mid Day Meal in the district of Paschim Medinipur or not.
- (2) If you accepted the said offer, did you take prior permission of the University authority in this regard ?
- (3) If yes, please provide a copy of the permission letter received from the University authority in this regard.
- (4) If not, please explain how did you accept such offer as an substantive employee of Vidyasagar University.

Resolved also that the Registrar of this University be requested to take necessary steps in this regard. Resolved further that the explanation of Shri Rout in this regard be placed in the next meeting of the Executive Council for further consideration.

- 06(j) To place before the Executive Council of Vidyasagar University, the letter dated 02.01.2018 submitted by Dr. Amal Kumar Bhunia, Assistant Registrar of Vidyasagar University pertaining to allow him to relinquish/forgo the offer of appointment for the post of Deputy Inspector of Colleges of Vidyasagar University.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 02.01.2018 submitted by Dr. Amal Kumar Bhunia, Assistant Registrar of Vidyasagar University stating that he has already submitted his application for availing the promotion under the Career Advancement Scheme with re-designation as Deputy Registrar of Vidyasagar University. In this connection he has requested to allow him to relinquish/forgo the offer of appointment issued by the University to him for the post of Deputy Inspector of Colleges of Vidyasagar University.

After careful consideration of the letter submitted by Dr. Amal Kumar Bhunia, Assistant Registrar of Vidyasagar University pertaining to allow him to relinquish/forgo the offer of appointment for the post of Deputy Inspector of Colleges of Vidyasagar University, it was resolved that prayer of Dr. Bhunia be relinquished from the post of Deputy Inspector of Colleges of Vidyasagar University as prayed for by him in his aforesaid letter. Resolved also that the offer letter for the post of Deputy Inspector of Colleges of this University be issued to the next person of the panel prepared by the Standing Committee constituted for this purpose. Resolved further that the Registrar be requested to issue the offer letter soon.



- 06(k) To consider the letter dated 30.01.2018 submitted by the Co-ordinator, SAP, DRS-II Project in the Department of English of this University pertaining to permission for holding the 42nd National Folklore Congress in Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 30.01.2018 submitted by the Co-ordinator, SAP, DRS-II Project in the Department of English of this University along with the resolution of the Departmental Committee in the Department of English of this University stating that as decided in the Departmental Committee in its meeting held on 25.01.2018, a proposal for holding the 42nd National Folklore Congress in Vidyasagar University was sent to the President of the Indian Folklore Congress which has finally accepted by the Congress Administration. The said Congress will be held tentatively on 16-18th November, 2018 in the University campus. There will be no financial obligation on the part of the University except a deal pertaining to the funds earmarked for conference and seminars in the SAP, DRS-II project budget in English. In this connection he has requested to permit them the said Congress in the University campus.*

*After thorough discussion on the letter submitted by the Co-ordinator, SAP, DRS-II Project in the Department of English of this University pertaining to permission for holding the 42nd National Folklore Congress in Vidyasagar University without any financial obligation on the part of the University and careful consideration of the decision taken by the Departmental Committee of English in its meeting held on 25.01.2018 in this regard, it was resolved that the said proposal of the Co-ordinator, SAP, DRS-II Project in the Department of English of this University be accepted in principle.*

- 06(l) To place before the Executive Council of Vidyasagar University, the letter bearing No. MS-Affi(VU)/17/SCHE/2018 dated 16.01.2018 received from the Member Secretary, West Bengal State Council of Higher Education regarding recommendation towards extension of affiliation of PG courses of Bhatler College, Dantan from the academic session 2018-2019.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing No. MS-Affi(VU)/17/SCHE/2018 dated 16.01.2018 received from the Member Secretary, West Bengal State Council of Higher Education along with the Inspection Reports for extension of affiliation of PG courses of Bhatler College, Dantan affiliated to Vidyasagar University stating that based on the request recommendation for affiliation of introduction of PG courses in Bhatler College, Dantan is being made subject to fulfillment of some conditions. The recommendation is made on the basis of observations made by the experts nominated by the council. The affiliating university is to make such exercises as required as per the norms of the University before giving formal approval for introduction of the said courses.*

*After thorough discussion on the recommendation towards extension of affiliation of PG courses of Bhatler College, Dantan from the academic session 2018-2019 made by the experts nominated by the Council and forwarded by the Member-Secretary, West Bengal State Council of Higher Education in this regard, it was resolved that the said recommendations of the WBCHSE be accepted and the Inspector of Colleges of this University be requested to process further in this regard as per the norms of the University.*



- 06(m) To place before the Executive Council of Vidyasagar University, the letter bearing F. No. 6-4/2013(SCT) dated 04.01.2018 received from the Under Secretary to the University Grants Commission, New Delhi pertaining to minutes and recommendations of the 15th National Review Meeting of the State Commissioners for Persons with Disabilities to Review implementation of Persons with Disabilities Act, 1995.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing F. No. 6-4/2013(SCT) dated 04.01.2018 received from the Under Secretary to the University Grants Commission, New Delhi along with the Office Memorandum of the Ministry of Human Resource Development, Department of Higher Education, Government of India regarding recommendations of 15th National Review Meeting of the State Commissioners for Persons with Disabilities to Review implementation of Persons with Disabilities Act, 1995 held on 17th & 18th May, 2017 requesting to provide the action taken report on the said recommendation. Resolved also that the Inspector of Colleges, the University Engineer, the Secretary, Faculty Councils for Postgraduate Studies and the Development Officer (Convener) of this University be requested to process further in this regard.*

- 06(n) To place before the Executive Council of Vidyasagar University, the letters issued to Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English of Vidyasagar University now under suspension pertaining to inspection of documents physically at the University related to the Chargesheet issued to her bearing No. VU/R/8EC-11/1525/2017 dated 24.11.2017 & to take further steps in this regard.



Charge sheet was issued to her bearing No. VU/R/8EC-11/1525/2017 dated 24.11.2017.*

*The Executive Council noted that various correspondences were made to Dr. Indrani Datta (Chaudhuri), Assistant Professor (under suspension), regarding her prayer for documents related to Charge Sheet bearing No. VU/R/8EC-11/1525/2017 dated 24.11.2017.*

*The Executive Council further noted that based on her prayer, she was asked to take inspection of documents listed in Annexure III of the Charge sheet on any working day with prior intimation and office letter No. VU/R/1637/2017 dated 20.12.2017 & No. VU/R/002/2018 dated 04.01.2018 were served on her to that effect. But she did not come to University for inspection, though scheduled time to reply to Charge sheet is long over.*

*After thorough discussion on the matter regarding issuance of different letters bearing No. VU/R/1551/2017 dated 30.11.2017, VU/R/1553/2017 dated 30.11.2017, No. VU/R/1637/2017 dated 20.12.2017, No. VU/R/1650/2017 dated 22.12.2017, No. VU/R/1666/2017 dated 29.12.2017, No. VU/R/002/2018 dated 04.01.2018 and No. VU/R/031/2018 dated 05.01.2018 etc. issued to Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English of Vidyasagar University (under suspension) pertaining to inspection of documents related to the Charge sheet issued to her and regarding her remaining physically absent at the University Quarters, it is resolved that as no satisfactory reply has been received in this regard till date, an Enquiry Officer be appointed, to enquire the whole matter regarding the Charge Sheet issued to Dr. Datta (Chaudhuri) bearing No. VU/R/8EC-11/1525/2017 dated 24.11.2017 and a Presenting Officer be appointed to place the case before the Enquiry Officer for the University.*

*Resolved further that Shri Shankar Coari be appointed as Enquiry Officer and that Dr. Avijit Roychoudhury, Inspector of Colleges of this University be requested to assist the enquiry officer for this particular case as Presenting Officer. The Registrar of This University is requested to convey this resolution to Shri Shankar Coari for his/her consent and after his/her consent reaches the University, to inform the same to all concerned including Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English (under suspension) by Official Notification.*

- (4) one student representative in each of the Postgraduate Department to be nominated by the Hon'ble Vice-Chancellor out of the panel of two students in each [one from 1st or 3rd semesters and another from 2nd or 4th semesters] prepared and submitted by the concerned Head of the Department in consultation with the Teachers-Students Committee.






- (5) one Research Scholar to be nominated by the Hon'ble Vice-Chancellor out of the panel of three Research Scholars prepared and submitted by the Vidyasagar University Research Scholar Association (VURSA).
- (6) one student in each of the M.Phil programme to be nominated by the Hon'ble Vice-Chancellor out of the panel of two students in each prepared and submitted by the concerned Head of the Department.

**Recommendations :** 07(a) To consider the recommendation of the Establishment Committee of Vidyasagar University for appointment to the post of Junior Assistant of Vidyasagar University.

**Resolution :** Resolved that the recommendation of the Establishment Committee of Vidyasagar University for appointment to the post of Junior Assistant of Vidyasagar University reserved for OBC-B be accepted and approved. Resolved also that the Registrar be requested to issue the offer letter to the concerned incumbent recommended by the Establishment Committee soon.

07(b) To consider the recommendations of the Standing Committee of Vidyasagar University for placement/promotion of Officers of Vidyasagar University under the Career Advancement Scheme.

**Resolution:** Resolved that the recommendations of the Standing Committee constituted for promotion/placement of Officers of this University under the Career Advancement Scheme as per the norms of the University in terms of the G.O. bearing No. 228-Edn(U) dated 08.03.2001 of the Higher Education Department, Government of West Bengal based on the views of the Screening Committee, constituted for screening of prima-facie eligibility for promotion/placement as per said G.O., along with the fulfillment of the conditions raised by the said Standing Committee and specified against each of the incumbent concerned in this regard be accepted and approved. Resolved also that the matter of promotion with re-designation/placement of Officers be brought to the notice of the Department of Higher Education, Science & Technology and Biotechnology, University Branch for their information and post-facto approval in this regard. The EC noted further that a declaration be obtained from the incumbent concerned, those who have been promoted with re-designation under CAS stating that in the event of non-concurrence of the Higher Education Department, Government of West Bengal in this regard, they may be duty bound to refund all financial benefits or part thereof that will be drawn by them as a result of their CAS and give up the elevated designation now offered to them by the University without any contest. Resolved further that all placement in the higher pay band and promotion by up-gradation of the existing post under the Career Advancement Scheme are personal to the incumbent concerned and after superannuation, resignation, death or otherwise of the person concerned, the base post will be released for direct recruitment.



- 07(c) To discuss the matter regarding holding the same designation by two Officers of this University after promotion under the Career Advancement Scheme.

**Resolution :** *The Executive Council of Vidyasagar University noted that after promotion under the Career Advancement Scheme, two incumbent concerned will hold the same designation as Deputy Registrar one from direct recruitment and another by promotion.*

*As both of them are the same designated person, it was resolved that Dr. Sukhendu Som appointed through direct recruitment be requested to look after the office of the Deputy Registrar (Academic) and Dr. Amal Kumar Bhunia who have been promoted to the post of Deputy Registrar under CAS will look after the office of the Deputy Registrar (Administration) henceforth and the Registrar be requested to issue a circular in this regard.*
