

## Resolutions:

Prof. Subrata Kr. De, Dean, Faculty of Sciences chaired the meeting in absence of Hon'ble Vice-Chancellor.

- 1. The proceedings of last PhD committee meeting held on 04.12.2017 were confirmed.
- 2. Matter regarding consideration of an appeal made by Ms. Monika Das for extension of Ph.D. thesis submission tenure; the PhD committee discussed the matter and it was resolved that Ms. Das may get 01 yr. (one year) extension to submit her PhD thesis as per Vidyasagar University rules.
- 3. Matter regarding consideration of an appeal to Hon'ble Vice-Chancellor and Secretary, PhD committee (Dated. 04.07.18) separately made by Mr. Debasis Bhunia for extension of Ph.D. thesis submission tenure; the PhD committee discussed the matter and it was resolved that Mr. Bhunia should submit his thesis before 20.10.2018.

- 4. Matter regarding minor revision of the title of the Ph.D. topic of Mr. Bubai Bera; the PhD committee has considered the appeal of Mr. Bera and resolved that the Studies in the Reproductive Ecology of two plants at a time will be herculean task for him. So, he is advised to work on a single plant (Canscora decussata) in detail and the new proposed title of the thesis i.e. "Studies in the Reproductive Ecology of a threatened medicinal plant Canscora decussata Roem & Schult in Tropics" may be approved during his PhD pre-submission seminar.

Or

- iv. Having experience in guiding Ph.D. thesis either independently / jointly.
- 6. Ph.D. pre-submission seminar was successfully delivered by Ms. Tripti Nandi (Ghosh) in presence of the members of PhD committee and her guide. The title of her Ph.D. thesis is "Melissopalynological investigation in understanding the Foraging Behavior of Apis mellifera L. used for Apicultural Practice in North 24 Parganas District and Adjoining areas of West Bengal".
