- 05(r) To place before the Enquiry Report submitted by the committee constituted by the University to access the necessity of a re-examination of Paper : 1.4.10 (Creating An Inclusive School) and Paper : 1.4(EPC-4) (Yoga Education : Self Understanding and Development) of the 4th semester B.Ed examination, 2018.

**Resolution:** *The Executive Council of Vidyasagar University noted the detailed report submitted by the Enquiry Committee constituted by the University to access the necessity of a re-examination of Paper Paper : 1.4.10 (Creating An Inclusive School) and Paper : 1.4(EPC-4) (Yoga Education : Self Understanding and Development) of the 4th semester B.Ed examination, 2018. The Executive Council also observed from the said enquiry report that there is no good reason to scrap the examinations held earlier and hold any such re-examination afresh as the examinations held previously on 27.06.2018 and 28.06.2018 stand legitimate and valid in the light of available evidences.*

- 05(s) To consider the proposal bearing letter dated 06.07.2018 submitted by the Secretary to the Vice-Chancellor to the Deputy Director, DDE & Transport-in-Charge for purchase of a new SUV with state-of-the-art safety car for use of the Hon'ble Vice-Chancellor of this University in view of the poor condition of the present vehicle used by him.

**Resolution:** *The Executive Council of Vidyasagar University noted the proposal bearing letter dated 06.07.2018 submitted by the Secretary to the*





Vice-Chancellor to the Deputy Director, DDE & Transport-in-Charge stating the Hon'ble Vice-Chancellor has to travel frequently on the highways to attend urgent official assignments and for this the existing Renault Duster (WB02AD8838) vehicle appears to be incapable of performing the duty as it has become weary since it is five years old and has surpassed its prime time. Considering the safety and security, a new SUV with state-of-the-art safety and other features for use by the Hon'ble Vice-Chancellor.

After thorough discussion on the proposal submitted by the Secretary to the Vice-Chancellor to the Deputy Director, DDE & Transport-in-Charge for purchase of a new SUV with state-of-the-art safety car for use of the Hon'ble Vice-Chancellor of this University in view of the poor condition of the present vehicle used by him, it was resolved that the said proposed car of SUV with state-of-the-art safety and other features be either purchased or procured on rent basis immediately from the University fund for use of the Hon'ble Vice-Chancellor of this University. Resolved further that the matter be forwarded to the Finance Committee of Vidyasagar University for noting.

- 05(t) To place before the Executive Council of Vidyasagar University, the note dated 05.07.2018 put forwarded by the Director (Officiating), DDE of Vidyasagar University pertaining to requirement of an experienced person (Controller -in-Charge level) to manage the huge work load in the Controller Section of DDE.

**Resolution:** The Executive Council of Vidyasagar University noted the proposal bearing note dated 05.07.2018 put forwarded by the Director (Officiating), DDE of Vidyasagar University stating that there is increasing work load day by day in the Controller Section of DDE for publication of different results within the specified time. In this connection the Officer-in-Charges has requested to increase 20(twenty) seats in each of Mathematics, Bengali, English, History, Philosophy and Political science and 50 (fifty) course in B.A. General.*

*After careful consideration of the letter submitted by the Officer-in-Charge, Govt. General Degree College, Dantan - II pertaining to increasing the intake capacity of some honours & general course (Arts) of Government General Degree College, Dantan-II with effect from the academic session 2018-2019, it was resolved that 20(twenty) seats in each of B.A./B.Sc. honours courses in Mathematics, Bengali, English, History, Philosophy and Political Science and fifty (50) seats in General discipline (Arts) in addition to the existing intake be increased from the academic session 2018-2019 duly recommended by the Inspector of Colleges of this University. Resolved further that the Inspector of Colleges of this University be requested to process further in this regard.*

**Resolution:** *The Executive Council of Vidyasagar University noted the note dated 11.07.2018 prepared and submitted by the Inspector of Colleges of this*





University stating that the Vidyasagar University may consider over the issue of continuation of affiliation of the Private Self-financing Colleges imparting Legal Education, as a considerable time and energy is being expended to regulate these colleges and overseeing the academic aspects of these colleges has become very intriguing in view of not possessing a postgraduate department of law in this University. Such discontinuation of affiliation may be necessary as law does not feature in the future academic expansion of the University.

After careful consideration of the proposal prepared and submitted by the Inspector of Colleges of this University pertaining to discontinuation of affiliation of four numbers of self-financing private Law Colleges from the academic session 2020-2021 as law does not feature in the future academic expansion of the University, it was resolved that the affiliation of four numbers of self-financing private Law Colleges, like, Haldia Law College, Midnapore Law College, R.M. Mies Law College and Sarsuna Law College may be discontinued from the academic session 2020-2021 as there is no postgraduate Department of Law in this University. Resolved also that the decision of the University Authority in this regard be intimated to the concerned law colleges for their information and necessary observations, if any, in this matter and they also be requested to explore the possibility of obtaining affiliation from a suitable University with a full fledged law faculty. Resolved further that extension of affiliation of these law colleges be continued for conducting the law courses which will commence from the academic sessions 2018-2019 and 2019-2020 till the end of the courses in the interest of the students already admitted for such courses.

- 05(z-1) To discuss the matter for engagement of contractual teachers in the Department of Master of Business Administration of this University based on the proposal submitted by the concerned department.

No. 612-Edn(CS) dated 01.06.2018 issued by the Department of Higher Education, Science & Technology and Biotechnology, Government of West Bengal for online admission in Undergraduate and Postgraduate courses in our esteemed institution for the academic session 2018-2019.

After thorough discussion on the letter received from the Director of Public Instruction, West Bengal pertaining to implementation of the Notification issued by the Department of Higher Education, Science & Technology and Biotechnology, Government of West Bengal, College Sponsored Branch regarding online admission for the Academic Session 2018-2019 to all UG and PG Courses in Govt. and Govt. Aided Colleges of West Bengal, it was resolved that said notification of Higher Education Department be implemented in this University for this purpose as advised by the Director of Public Instruction.
