Resolutions:-

Agenda 1:- The Proceedings of the previous meeting held on 07.02.2018 were read and confirmed.

Agenda 2:- The revision of the M.Sc. Syllabus in Anthropology is in progress. Photocopies of the preliminary draft of the syllabus on which the faculties worked on earlier were distributed among the faculty members. Each members were requested to give their comments and suggestions on the draft and place it in the next DC meeting.

Agenda 3:- Finalised list of books were prepared by the faculty members. The HoD was entrusted to do the needful in this regard.

Agenda 4:- The HoD reported that earlier Dr. Amit K. Kisku was nominated from the teachers to be in the teacher-student committee. Dr. S. Sarker was the ex-officio member of the committee. Mr. David Benjamin Hansda of Fourth Semester (Class Roll no. ) was the representative

class rep. no. was nominated by the students of the concerned class to participate in the teacher-student committee meeting, since they did not have a class representative. The HoD now consulted the students of the second semester and the students opined that Mr. Amit Kumar Maji will represent them in the teacher-student committee.

The members of DE unanimously accepted the name of Mr. Amit Kumar Maji as new member of the teacher-student committee. The DE further resolved that, Mr. Shimul Roy will be the new member of the said committee replacing Dr. S. Swikar.
