Resolutions:-

Agenda 1 :- The proceedings of the previous DC meeting held on 15/02/18 were read and confirmed.

Agenda 2 :- Comments and suggestions were already given on the preliminary draft of the revised syllabus in the previous DC meeting. In the present DC meeting Prof. D. Midya placed a draft of the revised syllabus in which previous comments and suggestions were already incorporated. After due deliberation, the committee members finalised the structure of proposed revised syllabus. It was further resolved that few changes need to be incorporated in each of the individual courses and their contents. The same will be finalised in the next DC meeting.

Agenda 3 :- The HOD informed the DC that he has sent a proposal for an Add-on course on Research Methodology to the Secretary, Faculty Councils for PG Studies on the date 21/02/2018, as per the decision adopted in the previous 03 (three) DC meetings held on the dates 19.12.2017, 11.01.2018, and 07.02.2018.

on the Dept. of Anthropology, VU, the members of DC unanimously resolved that the name will be introduced as per the general guidelines of the University regarding the starting of Add-on course.

Agenda 4:— The HoD informed the DC that a new Ph.D. Committee in Anthropology was formed on 30.10.2017 in terms of the provision 3.1 of the PhD regulations of VidyaSagar University. Dr. Sovanjan Sarkar was appointed as the Secretary of the committee, who was also the TIC of the department at that time. Dr. Amit Kisku ~~is~~ a member of the said committee. Now Dr. Kisku has become the HoD of Anthropology and as per the provision 3.2 of the PhD Regulations of VidyaSagar University "The Head of the Post-Graduate Department concerned shall act as the Secretary of the PhD Committee". The HoD drew attention of the DC members on two considerations - a) The new PhD committee was constituted in terms of the provision 3.1 of the PhD Regulations, and b) Dr. Sarkar was appointed as Secretary of the Committee by his name. The HoD sought suggestions of the DC members under the above two considerations that whether provision 3.2 of the PhD Regulations, VU will be applied in the composition of the new PhD Committee in Anthropology and consecutively whether Dr. Kisku will act as the Secretary of the PhD Committee in Anthropology being the Head of the Department of Anthropology, VU.

After due deliberation, the members of DC unanimously resolved that the HoD may write a letter to the Honble Vice-Chancellor for necessary suggestions in this regard.

Agenda 5:—
