Govt. of West Bengal and Rs. 1.00 crore was already disbursed from Higher Education. Govt. of West Bengal for university network upgradation/ expansion project based on the project proposal submitted by WBEIDC.

The sanction was placed in W & T committee for discussion. It has been resolved in W & T that a I.OI may be issued to WBEIDC for implementation of the Project with an intimation to the funding agency.
