### Questions and Suggestions

#### Professor Sujata Sen:

1. Suggestion - Use the term solution of "cases" instead of using the term "sample" since this is a qualitative work.
2. Make a separate section on relation between migration and HIV cases.
3. Experiences during the Pandemic situation can be incorporated.
4. Use the term Analysis/Understanding/Interpretation instead of "Findings" (Label can be given as conclusion and suggestions)
5. Questions : Since the research has attempted at an understanding of stigma in complex social situations, how can you interpret these complex social phenomena as a researcher?
6. Highlight on suggesting policies : How can you as a Sociologist help in framing policies in this context ?

#### Professor Ruby Jain :

1. Suggestion : Epidemiology in Medical Sociology should be mentioned
2. Only Goffman's theory on stigma has been accepted and used by you. Also add Sutherland's labelling theory. [ Joydeb's response : Added labelling theory already in research ]
3. Add more cases applying snow-ball sampling and undertaking qualitative strategies since 20 respondents is too a less number. [ Joydeb's response : Difficult to conduct research on HIV patients in hospital set-ups. ]
4. Explain the role of governmental and non-governmental agencies in this kind of diseases. Explain the role of WHO as well.

#### DR. Asmita Bhattacharyya :

1. Suggestion : Objectives should be precise.
2. Question : Why the term "semi-structured" has been used instead of interview guide / schedule considering this is a qualitative research ?
