**Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing No. BIBS/VU/R/8EC-06/C0091(1)/2019 dated 23.10.2019 submitted by the Principal, Bengal Institute of Business Studies (BIBS), Kolkata stating that at the time of submission of documentations and payment of the students for the batch of 2019-2021 for registration, they were informed by the Department that the Enlistment Fees for regular M.B.A. Programme has been increased from 2,000/- (Rupees Two Thousand) only to Rs.5,000/- (Rupees Five Thousand) only per semester. **Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing No. BIBS/452/19-20/R/EX/2019 dated 31.10.2019 submitted by the Principal, Bengal Institute of Business Studies (BIBS), Kolkata stating that at the present moment the candidature of 105(one hundred and Five) students are on hold since they have less than the requisite percentage of marks (45%) in graduation level but have passed from their respective Universities. Many students of our states are failing to avail job oriented courses within the state because of the stipulation on qualifying percentage and are moving to other states or seeking alternative options. In this connection he has requested to consider the candidatures of these students to pursue the said regular M.B.A. course from our University and help them to shape up their future.*

*After thorough discussion on the letter submitted by the Principal, Bengal Institute of Business Studies (BIBS), Kolkata pertaining to permission for the students having less than 45% marks in graduation level for registration and appearing before the first semester examination in regular M.B.A. Programme, it was resolved that one hundred and five (105) students having less than 45% in graduation level be permitted for registration and also to sit the first semester examinations in regular M.B.A. Programme of Vidyasagar University conducted by BIBS as a special case provided that an amount of Rs.1,000/- (Rupees One Thousand) only per candidate including super late fine be deposited to the University by the Institution concerned for this purpose. Resolved further that the Inspector of Colleges of this University be requested to do the needful in this regard in consultation with the Secretary, Faculty Councils for Postgraduate Studies of this University.*


