The method of argumentation is very technical. Ph.D committee members were convinced by the prayer of the candidate. It was unanimously resolved that for the satisfactory completion of the proposed work, the application of the candidate be recommended to Hon'ble Vice Chancellor for his kind permission in favour of the candidate.

6. Sri Nitai Das submitted a prayer for writing the thesis in Bengali. Members of the P.D. work committee were convinced that as the P.D. work would require the study of the Text books in Sanskrit and Bengali, the work might be well done only in Bengali.
