COMPLAINS/PROBLEMS & RESOLUTIONS TAKEN.

- 1) The resolutions of the previous meeting were read and confirmed.
2) The second semester students requested to the department for the keys for the easy access of the departmental library.

In response to the request it is resolved that the HOD will notice ~~about~~ the things ~~and~~ to access the DL as well as ^{she} will ~~not~~ notice the whereabouts and the information ^{on} regarding the in-charge of the said matter.

- 3) The fourth semester students requested to the department to use the departmental computers for completion of their project ~~and~~ work mandatory for the completion of 4th semester philosophy PG course.

It is resolved that the department will take positive attitude regarding this matter. The HOD is ~~requested~~ requested to issue a notice containing the rules and regulations to use the computers.

- 4) All the students requested to install an water purifier with cool water making capacity and to clean regularly the departmental larva situated in the ^{common} corridor between Computer Science, Sanskrit and philosophy department.

It is resolved that the HOD will take proper initiative regarding this matter and will write letters to the appropriate authority.

- 5) All the female students complain to the department regarding the ^{lack of} sanitization and clearing, and insufficient unhygienic infrastructure of the Ladies toilet. They also request for the availability of sanitary napkins as and when required.

It is resolved that the department will take sincere initiative regarding this very crucial

women health related issue. The HOD and all the female faculties are requested to take proper initiative with the help of university administration.

10. The students representatives of the teacher-student committee also points out some more crucial matters states herewith:—

- The existing microphone situated in the room no. 211 is not working properly.
- To ~~issue~~^{publish} the internal assessment result in the departmental notice board.
- To use projectors to make philosophy classes more attractive and understandable.
- They requested for more boardwork (from the part of the faculties) for the better understanding of the subject.

It is resolved that the department will take initiatives to resolve the aforesaid matters following the Vidyasagar University rules and regulation. Also, all the faculties are requested to look into the ^{said} matter and if at all possible to resolve there by means of their personal capabilities.
